THE mother of a toddler killed by a convicted paedophile in a hit-run crash says her ongoing grief is so all-consuming that it feels "like dying, but they've forgotten to bury me".

The District Court yesterday heard a victim impact statement written by Chantelle Young, mother of Zayne Coulson. Zayne died outside his home when he was run over by Michael Craig Bullock, who did not stop after the impact.

Ms Young said she and Zayne's six siblings remained distraught over his loss and wondered, every day, what life would be like had Bullock stopned his car.

"Grief would have to be the worst feeling ever, it's like dying but they have forgotten to bury me," she said.

"I was disgusted (Bullock) could do this to my family (and) still plead not guilty ... he has shown no remorse or sym-

pathy for his actions.

"Zayne did not deserve to die like this ... Bullock, my family feels that if you stopped like you should have, Zayne could possibly still be here today."

Bullock, 54, was found guilty by a jury of one aggravated count of driving without due care and one count of leaving an accident scene.

The charges arose from his driving conduct at Dover Gardens in February 2017, which caused the death of Zayne, 2.

"Our hearts feel like they have broken into a million pieces," she said.

"Some days, it's like living two lives ... we put on a brave face but, deep down inside, we're broken.

"We're angry ... while Bullock has spent the past two years at home with his family, still getting to speak to his loved ones, we are left with a death sentence and nothing

ters, when he was hit, dragged beneath Bullock's car for several metres and left lying on the road.

Bullock drove 100m to his house, where his wife contacted emergency services and he told the operator "I didn't stop, it wasn't safe".

He claimed, at trial, he had swerved to miss another child and thought he had hit a ball at the time of the incident – jurors rejected his account.

Bullock has past convictions for child sex offending, sexual assault upon a teenager and possession of child

for Bullock, said his client's appeal against his conviction would be heard tomorrow.
He said Bullock maintained he did not stop at the scene because he was heading home to call the police.
"There is not a 'complete absence of contrition' in this matter," he said.
"There's a denial of the elements of the offence, and that's maintained, but there's never been a suggestion that he doesn't wish that these events didn't happen.

Mr Redford read to the court a letter of apology written by Bullock.

"I would like to take this opportunity to apologise to Zayne's family for all the pain and suffering I've caused and for any evidence they may have found distressing," he said.

"It's unimaginable to think what you are going through, every minute of every day ... once again, I'm truly sorry for your loss."

Judge Paul Cuthbertson remanded Bullock in custody for sentencing next month.

sex GP suspend acts to regulator Medical

AN Adelaide GP guilty of sexual misconduct against multiple female patients has been suspended as he awaits punishment, the country's medical regulator has amnounced.

Convicted sex predator Dr Mario Athinodorou, 52, breached professional medical boundaries with 10 women at the Harbour Medical Services' North Haven surgery over at least 15 years.


He said national boards had power to take interim action to restrict a health practitioner's right to practise.

"A national board may take immediate action where it reasonably believes a health practitioner is placing the public at serious risk or it is otherwise in the public interest to do so," he said. "The restriction on a health practitioner's ability to practise can include suspension of registration, imposition of conditions or accepting an undertaking."

During tribunal hearings over the past 14 months, the four-member tribunal panel heard graphic evidence about his sexual behaviour.

This included kissing, hugging and groping women, asking them to undress and undertaking intimate medical examinations without a chaperone being offered or present.

The GP denied the claims.
