The Program

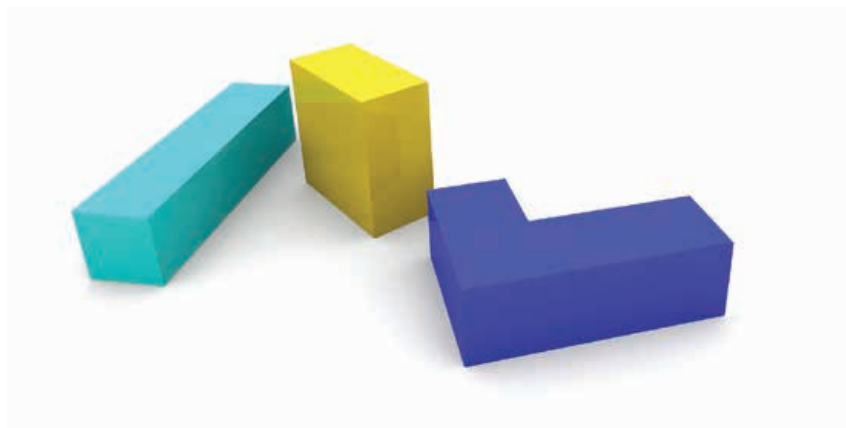
We are pleased to announce that **The Hon. Mark Butler**, MP, Minister for Mental Health and Ageing will open the event with a recorded message.

Leesa Vlahos, MP, Parliamentary Secretary to the Premier (TBC) will welcome the participants to SA and release the draft South Australia Safeguarding Older Adults Strategy for key stakeholder consultation.

The Hon. Susan Ryan AO, Age Discrimination Commissioner will discuss how the Australian Human Rights Commission can assist in raising awareness and informing a national approach for preventing and responding to elder abuse

Dr John Brayley, Public Advocate SA, will review the work of Australian Guardianship and Administration Council and its members in areas relevant to preventing and responding to elder abuse in his presentation “National Development in Guardianship and Administration relevant to Preventing and Responding to Elder Abuse”.

Master of Ceremonies is **Dr Sally Cockburn**, (aka Dr Feelgood), a high profile media presenter (ranked in the top 10 speakers in Australia), who champions those who feel disempowered.

Keynote Speaker

Paul Greenwood, Deputy District Attorney, Head of Elder Abuse Prosecution Unit, San Diego DA's Office, returns to Adelaide to inspire us with his prosecutorial panache. Paul's presentation 'Elder Abuse - a local problem requiring a national response' will draw upon Paul's 17 years' experience of prosecuting elder abuse in showing why the time is right to develop a national strategy to combat this escalating crime in Australia. He will discuss various misconceptions that often prevent a case from being investigated and prosecuted, and he will highlight successful multi-disciplinary strategies that provide an effective community response.

Plenary Speakers

Plenary speakers include a range of experts from across the disciplines:

Professor Simon Biggs, Professor of Gerontology and Social Policy, University of Melbourne, will examine recent international findings on elder mistreatment and identify some of the key trends.

Ian Yates, Chief Executive of COTA Australia and Sponsor Member of the National Aged Care Alliance will outline a proposed framework for a national advocacy program covering residential aged care, a greatly expanded in-home care program, the Home Support Program, and prevention of elder abuse.

Mark Crofton, the Official Solicitor, Qld Public Trustee, will present insights into financial elder abuse from his Churchill Fellowship research.

Susan Emerson, Director, Care Environments and Service Strategy, Helping Hand Aged Care, will describe how the aged care sector can bring about a zero tolerance environment.

Concurrent Sessions

Response agencies across Australia will showcase their research, innovations and programs that assist older people to prevent abuse or further abuse. There will be opportunities to explore the key themes in elder abuse in these sessions, with case reflections to demonstrate practice and paint a picture of what is happening in Australia to date. Presenters will cover a range of innovations including client data collection systems, CaLD research, Aboriginal community development models and the power of developing multi - sectoral alliances.

Panel

Representatives from State and Territory governments will present what is happening in their region to prevent abuse - from protocols to television campaigns. They will also be asked to consider how a national agenda could be forged to increase the effectiveness and efficiency of the response to elder abuse. The panel session will be at the end of day two in order to summarise what has taken place previously - make sure you stay for this session which will address the way forward!

Raising Awareness in the Community

Numerous WEAAD activities have been held in the community to raise awareness and a kaleidoscope of these will be presented to inspire us all to be involved in WEAAD in any way we can.

Mark Aiston, the popular media personality with Network Ten and Mix 102.3, will showcase how we can all use the media to raise awareness of elder abuse.

The program will interest the community and residential aged care sector, legal workers, medical and hospital staff, academia and the financial industry - in fact everyone who has an interest in raising the profile and furthering their knowledge in this challenging field.

Conference Venue

Car Parking

Under the Hon Jack Snelling MP, Minister for Health and Ageing, Office for the Ageing is reviewing *Our Actions to Prevent the Abuse of Older South Australians (2007)*. The involvement of lead agencies from various sectors, and wide, aged care sector consultations are part of this review.

The review will develop a state-wide abuse prevention strategy to inform policy and guide future actions for abuse prevention in South Australia. It will strengthen risk identification, prevention and responding to the abuse of older people.

Implementation of the state-wide strategy will be based on shared responsibility and the collaborative action of agencies across state, local and non-government. This will include those already involved in the care of older people, as well as broader community services that older people access.

Resthaven Incorporated

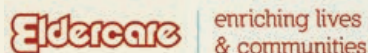

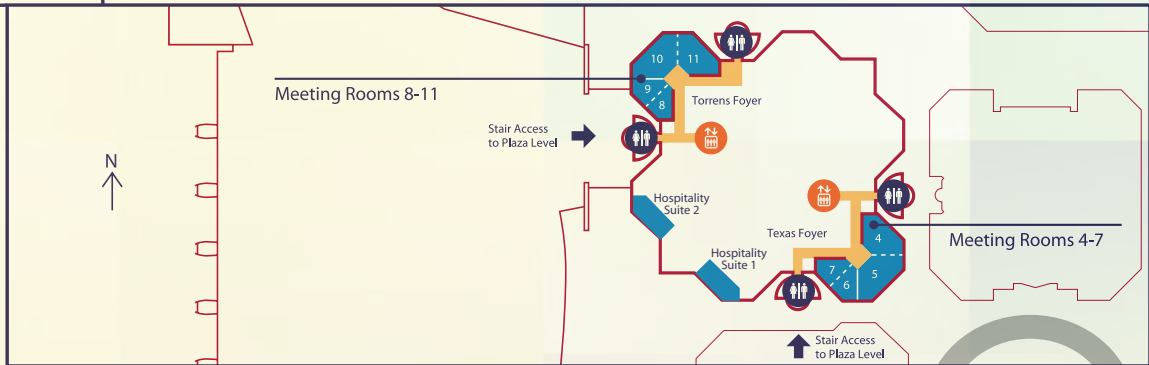

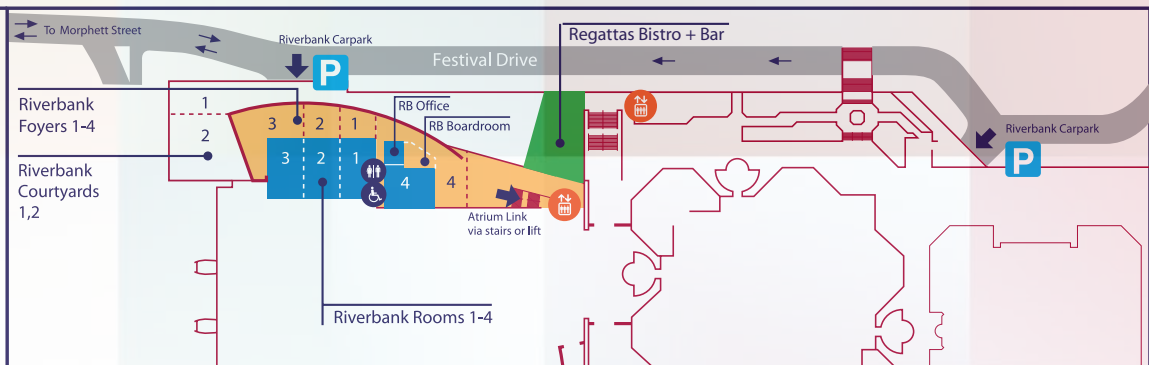
